FEBRUARY 25, 2021 BOARD MEETING

Election of Board Chairperson

Kerrie Vanden Bosch stated the first item of business was election of the Board's Officers for 2021. Ms. Vanden Bosch conducted the election for Chairperson. Nominations were declared open. James Wiersma nominated Michael Brown for Chairperson of the Retirement Board for 2021; supported by Jason Sarata. Motion carried.

Election of Board Vice-Chair

Chairperson Brown conducted the election for Vice-Chair. Nominations were declared open. Mary Sholander nominated Jason Sarata for Vice-Chairperson of the Retirement Board for 2021; supported by John Ogden. Motion carried.

Open Meetings Act Procedure Review and Approval

Ms. Bellar presented recommended Open Meetings Act Procedures pursuant to her February 2, 2021 Memorandum to Ms. Vanden Bosch. After review, Mr. Ogden moved to approve the Procedures; supported by Ms. Rotman. Motion carried.

Investment Policy Statements for Institutional Funds and Participant Directed Accounts

Michael Charette reminded the Board that minor revisions to the Investment Policy Statements for Institutional Funds and Participant Directed Accounts were presented at the December 3, 2020 meeting, and it is now time to approve the revisions. MERS DB Lump-Sum Payout Concept with Plan Amendments and Actuarial Policy
